EXHIBIT RELEASE - All exhibits will be released at 9 pm on Saturday, August 2, 2025. Please do not remove exhibits until the release time.

All entries will be under the care and control of the Rush County Agricultural and Fair Association, Inc. (RCAFA) and while due care and caution will be exercised for their safe keeping, neither the RCAFA, its officers, agents or employees will be responsible in any case of loss, injury or damage that may occur. The management will adequately police the grounds, but the RCAFA will not be responsible for loss, theft or damage of personal property on the grounds. Correspondence on all matters pertaining to the fair will receive prompt attention from either the secretary or department superintendent(s).

In case of inclement weather, events scheduled for the day may be postponed and/or cancelled and premiums may be prorated at the discretion of RCAFA.

RCAFA reserves the sole and absolute right to construe its own rules and regulations and to determine arbitrarily all matters of rule.

NO DOGS ARE ALLOWED ON THE FAIR GROUNDS except service dogs or those entered in competition.

Special Awards

RCAFA does allow the donation of special awards in addition to the general premiums awarded in Open Class and 4-H competitions. All special award donations must be approved by RCAFA no later than the May meeting of the current year. Special awards not approved by the May meeting cannot be awarded in the current year and will not be considered until the following year. Special awards must be presented at the conclusion of the event either by the donor or a designated representative unless prior approval is given to RCAFA. See individual departments for special awards and description.

OPEN CLASS GENERAL RULES

- 1. Any resident of Kansas may enter in the Rush County Fair.
- 2. Age is determined as of January 1, 2025.
- 3.Exhibitors in all Departments will be divided into the following divisions: **Junior** = 10 & under

Youth = 11 to 18

Adult = 19 to 64

Senior = 65 & OVER

Professional = Those who are teachers of a specific skill and/or have been paid for their products, services and/or knowledge.

- 4. Pre Entry available online through fairentry.com Or Day of Entry at stations throughout the buildings.
- 5. Exhibitors may enter 2 exhibits in each class unless otherwise stated. All animals and articles exhibited for premiums must be recorded in each department.
- 6.Entries must be produced by the exhibitor. Articles produced within the past 4 years may be entered, however, articles previously entered in open class at the Rush County Fair are ineligible.
- 7.Only 1 blue and 1 red and 1 white (if given) ribbon will be awarded in each class. The blues in each section are used to determine the Champion and Reserve Champion in each department. Each department will award a maximum of two Champions and two Reserve Champions from first place class winners. The competition for one Champion and Reserve Champion will be among the combined entries in the Junior and Youth Divisions. The other Champion and Reserve Champion will be awarded from the Adult, Senior and Professional Division entries as a combined competition unless otherwise noted in a specific department.
- 8. Any resident of the State of Kansas may exhibit in the Open Class division of the Kansas State Fair. Exhibitors DO NOT need to qualify at the county level to exhibit at the state level, however, ALL Kansas State Fair entries must be pre-entered. See www.KansasStateFair.com to download an exhibitor handbook and entry form. It is the responsibility of the exhibitor to enter the correct size and/or quantity required for display.
- 9. When there is no competition, articles will be awarded first, second, third or none at the discretion of the judge.
- 10.PREMIUMS-Unless noted in specific departments, placings and premiums in each class are as follows: First-\$3 Second-\$2 Third-\$1

Ribbons will be given to the Pee Wee Class.
Ribbons may be collected at the Fair Office at time of premium payment.

- 11.Premiums will be paid in cash at the Fair Office from 6:00 7:30 p.m. on Saturday, Aug. 2. Checks will not be written or mailed for any unclaimed premiums less than \$10.
- 12.No premium will be paid on animals or exhibits removed from the fairgrounds before the close of the fair without the permission of the Department Superintendent. Owners of premium stock refusing to exhibit at the time indicated on the program forfeit the premium award.

OPEN CLASS LIVESTOCK GENERAL RULES

Premiums- Beef First \$25 Second \$15 Third \$10 Swine, Sheep, Goats First \$15 Second \$10 Third \$5 Animals exhibited must be owned by the exhibitor and be of approved pedigree. Pedigree or affidavit is required. This rule does not apply to the commercial female class.

- 1. Any recognized breed will be eligible to show.
- 2. Each individual animal may be entered in only one class as a single, one of a herd, flock, group or pair. A 4-H animal may enter open class in the appropriate class. 4-H bucket calves may not enter open class breeding classes.
- 3.Bedding will be provided by the Fair Board as needed for beef, swine and goats. Sheep exhibitors may want to provide bedding for their exhibits. A maximum of 4 animals per pen allowed.
- 4. Any exhibitor not caring for their animal will be given 3 warnings, then the animal will be sent home and premiums forfeited.
- 5.All animals entered for exhibition will be subject to inspection by RCAFA and/or its representatives and shall be free of clinical signs of infections or contagious diseases. Any animal deemed unhealthy according to the RCAFA Animal Health Requirements will be refused admittance to the fair grounds.
- 6.Livestock competition will be shown in different breeds if three animals of one breed are entered in a class. Breeds will be shown together if less than three animals of one breed are entered.

OPEN CLASS AND 4-H ANIMALS HEALTH REQUIREMENTS

GENERAL REQUIREMENTS

All animals are subject to examination by the exhibition staff or their representatives, and shall be free of clinical sign of infectious or contagious disease. **Health certificates and additional requirements shall be a county option.**

CATTLE AND BISON—The Kansas Animal Health Department (KAHD) requires no test on cattle and bison of Kansas origin. Cattle determined by RCAFA to have lesions of ringworm, warts or infested with mange will not be permitted to exhibit.

SWINE—Swine originating in Kansas must meet the general requirements. Kansas has obtained Stage V status in the National Pseudorabies Program and the state is classified free of swine brucellosis. **A negative pseudorabies and brucellosis test are not required for Kansas origin swine**.

SHEEP—In addition to the general requirements sheep shall: be free of any signs of "sore mouth", be free of signs of active fungal (ringworm) infection, including club lamb fungus. All sexually intact (ewes & rams) and wethers must be identified with an official USDA premise ID tag. Lambs, under 8 weeks of age, accompanying their dams are exempt from tagging requirements.

GOATS—Goats shall meet the general requirements. Goats determined by exhibition staff to have sore mouth, lesions of ringworm, warts or infested with mange will not be permitted to exhibit. All sexually intact (does & bucks) and wethers must be identified with a registered tattoo or an official USDA premise ID tag. Kids, under 8 weeks of age, accompanying their dams, are exempt from identification requirements.

HORSES—Horses shall meet the general requirements. A negative test for Coggins & West Nile Virus is recommended but not required.

POULTRY—All poultry, except waterfowl, must show proof that they are pullorum-typhoid clean by one of the following methods.

- * Present an official VS 9-2 Form, signed by an official testing agent showing the entries have had a negative pullorum-typhoid test within the proceeding 90 days.
- * A VS 9-2 Form must be completed for each entry. If any birds in an entry test positive for pullorum-typhoid, the entire entry as well as all other birds from the same premises will be refused.

RABBITS—Any rabbit having a white nasal discharge, noticeable eye discharge, mange or scurvy condition with flakes resembling dandruff, or infestation by mites, fleas or lice, will not be allowed to show and will need to be immediately removed from the fairgrounds.

- 1. Exhibitors may only enter in one division. **No more than two entries per class.** Division is determined by exhibitors age on January 1 of the current year.
- 2. Photo must have been taken by the exhibitor, upon request exhibitor must be able to describe how the picture was taken.
- 3. Black & white OR color photos may be exhibited. Any type of camera may be used.

- 4. Overall size of exhibit (photo plus mount/matte) must be no smaller than 11×12.5 " and no larger than 11×14 ". Minimum visible photo size is 5×5 ".
- 5. Use only adhesives designed for permanent photography mounting. Do not use double stick tape, rubber cement or other household glues. These products cause buckling, stains or lumps in photo surfaces
- 6. Photos must be permanently mounted on matte board or foam core board, NOT poster board. Mattes are permitted and may be any color. Matte cut may be any shape (rectangle, circle, oval, square, triangle, etc.)
- 7. Photos may be mounted/matted vertically or horizontally. Matte board is available for purchase at Walnut Creek Extension office. Frames and glass are not allowed. No lettering is permitted on the front of the photo, mount or matte. (Dates are considered lettering) Contact prints on front of the mount or matte are not allowed. White borders are not allowed on prints.
- 8. Must be entered in with a photo sleeve. Clear photo sleeves are available for purchase at the Walnut Creek Extension office, 702 Main Street in La Crosse.
- Each entry must have the exhibitor's name, address, phone number, class number and class name written on the back of the matte.
- 10. Photos not meeting these requirements will be disqualified. Champion and Reserve Champion will be awarded from Junior and Youth divisions combined and Adult, Senior and Professional combined from the first place class winners. For description of divisions see page 6.

Section 1- PHOTOGRAPHY

- Class 01 **Action**-illustrating action or movement of any subject. Action or movement must be visible or implied.
- Class 02 **Animal Life**-must illustrate some aspect of a living animal's existence.
- Class 03 **Agriculture**-any subject relating to the science or practice of farming, including the rearing of crops and animals.
- Class 04 **Architecture**-must include a building or other man made structure at any stage of construction.
- Class 05 **Everyday Life**-must illustrate some aspect of someone's daily existence.
- Class 06 **Fair Theme**-any subject that is directly related to a fair.
- Class 07 **Human-Animal Bond**-must illustrate the way people and their animals are connected, the way they behave toward each other, or the relationship between people and their animals. Must have both a person and an animal in the photo.
- Class 08 **Human Interest**-photograph depicting the activity of a person or group in a way that evokes interest, sympathy or curiosity in the viewer. A human must be visible.

- Class 09 **Humorous**-must illustrate something that causes amusement or a sense of humor.
- Class 10 **Landscape/Seascape**-must illustrate an area of countryside, city or expanse of sea, land, or sky with a definite subject. Structures may be included if they enhance the scene.
- Class 11 **Macro**-extreme close-ups of any subject shot with close-up filters, macro lenses or any other macro technique.
- Class 12 **Miscellaneous**-any subject or technique that does not fit into any other class. May not be another photo of a subject already entered in another class.
- Class 13 **Nature**-any subject from the physical world, including plants, animals, the landscape and natural phenomena, as opposed to humans or human creations.
- Class 14 **Photojournalism**-the communicating of news by a photo.
- Class 15 **Photo Essay**-consists of 3 to 8 photos aesthetically arranged to tell a complete visual story. The main photo must be at least "5x7" and no larger that 8x10". Supplemental photos may be mounted in any order and in any pattern on a sheet of mount board or foam core board not larger than 16x20". Photo essays may be vertical or horizontal. A title or headline may be included and it should be neatly printed. Adhesive letters may be used.
- Class 16 **Portrait-Animal**-an artistic representation of an animal, posed, formal or informal.
- Class 17 **Portrait-Formal**-an artistic representation of a person, posed and close-up (typically, head and shoulders); in business or formal attire.
- Class 18 **Portrait-Informal**-an artistic representation of a person; relaxed, friendly and unofficial; usually in casual, everyday clothing.
- Class 19 **Reflection**-an image formed by the phenomenon of light, heat, sound, etc. being reflected.
- Class 20 **Computer Manipulation**-the application of image editing techniques to photographs in order to create an illusion or deception. Adjustments of hue, tone and brightness and contrast enhancements are not considered manipulation. A print of the original image (4x6 only) must be included.
- Class 21 **Sports**-activities involving physical exertion and skill in which an individual or team competes against another or others. May be traditional or extreme sports.
- Class 22 **Still Life**-an arrangement of inanimate objects.

Ouality Criteria

- 1. FILLED JAR
- * <u>Headspace</u> must correspond to instructions on the jar and lid packaging or the reference guides listed. The top of the

31

- finished recipe or liquid covering produce should provide adequate headspace as stated in approved guidelines.
- *Air bubbles must be kept to a minimum. Gas bubbles denote spoilage; they are identified by movement of bubbles to the surface of the product while the jar is stationary.
- *Bands should remain in place to transport preserved food. Remove bands carefully to determine if the headspace is correct. Replace bands for product display.

2. HEAT PROCESS

- *Methods used to heat process foods must comply with current preserving guidelines as stated in the approved reference guides. The boiling water process for acid foods and steam pressure process for low acid foods are the only recommended methods to heat process foods for shelf storage.
- *Times for heat processing preserved foods correctly vary depending on each specific recipe or food type. Processing times must be in agreement with those listed in the approved reference guides.

3. PRODUCE APPEARANCE

- *Produce should be free from blemishes, stems, pits and peels. Some recipes may state stems, pits and peels are not removed, this is acceptable if the recipe is in keeping with all other preserving guidelines.
- *Liquid must be clear and free from cloudiness and small particles unless there are ingredients added to the recipe that would naturally affect its clarity.
- *Color of the finished product should be as close to its natural characteristics as possible or standard for cooked product.
- *Texture is affected by heat processing; however, the finished product should not appear over cooked or break down.
- *Ingredients should retain their shape and size based on the type and preparation method. Cut pieces, of uniform size, should be packed evenly in the jar yet allow adequate room for liquid to circulate throughout the jar.
- *Safety is of utmost importance. Any entry exhibiting spoilage or not in compliance with judging guidelines *must be disqualified.*

Rules:

- 1. All food preservation entries must have been canned after previous fair. All jars must be sealed and of standard size with rings free of rust.
- 2. Labels are **REQUIRED**. The label must not cover brand name of jar. The label must give: Class number, product, altitude where processed, canning method (water bath, weighted gauge or dial gauge pressure method), process time, pressure (psi), date processed including month & year, name and county/district. One jar is required for each entry. Label templates may be found at http://www.kansas4h.org/p.aspx? tabid=46
- 3. Recipes must be attached to each entry. Only one jar of each product is required. Open kettle canning is prohibited.
- 4. WILL NOT BE SOLD AT THE FOOD AUCTION

RUSH COUNTY 4-H GENERAL RULES



- 1. Open only to enrolled 4-H members of Rush County. Must be enrolled in the project area to be able to compete. Exhibits must be the result of current project year work.
- Age is determined as of January 1 of current year. Members who are 7-12 years old compete in the Junior Division unless otherwise specified. Members who are 13 years old and older compete in the Senior Division unless otherwise specified.
- 3. CLOVERBUD RULES The Cloverbud Program is available for 4-H members age 5 and 6 years old. Cloverbuds is an activity based program, not project based, and therefore will not receive any premiums for entries. However, they will participate in consultation judging and be awarded a Cloverbud ribbon. They will be allowed a maximum of 6 entries total in the fair. Cloverbuds are allowed to show pets from the following list: Amphibians (frogs, toads), Ant farms, Cats, Dogs, Fish, Gerbils, Guinea Pigs, Hamsters, Mice, Parakeets, Rabbits, Rats
 - Food items entered by Cloverbuds CANNOT be sold at the Food Auction.
- 4. Food Auction will be held on Wednesday, July 30, immediately following the Opening Ceremony (approximately 6 pm). 4-H'er must abide by rules of the Rush County Premium Auction. All 4-H food members will need to fill out a food auction label located at the entry table before foods judging. All 4-H food members will receive 93% of their proceeds from the food auction. For the members to receive this, they will need to present their food item during the auction. If not able to present food at auction because of a conflict, prior arrangements **must** be made with 4-H agent prior to the event. If you are not present and no prior arrangements have been made, your proceeds will default to 4-H Council. **Any exhibit that requires 3 items for judging will need to bring 12 items to qualify for the auction**.
- 5. Items constructed in Walnut Creek Extension sponsored classes and day camps may be exhibited in the corresponding project area provided 4-H'er is enrolled in that project.
- 6. Consultation (interview) judging will be used in all project areas except livestock. Visual Arts and Foods consultation judging will start at 8:00 a.m., Wednesday, July 30. 4-H'ers will be assigned a schedule. 4-H'ers will need to be there to meet with the judge. If you miss your assigned time you will need to wait until the end of the daily judging schedule to meet with the judge. All exhibits to be entered by 10 am with the exception of visual arts, foods and Cloverbuds.
- 7. Two entries per class, a maximum of 6 per person per project area, unless other wise stated.

- 8. PRE-ENTRIES—All 4-H exhibits must be pre-entered by July 15 on fairentry.com. Booth and display space must be reserved by July 15.
- 9. Shopping in Style (Fashion Revue), Sewing and Textiles, Fiber Arts & Photography Judging will start at 9 a.m. on Monday, July 28. The Public Fashion Revue will be held at 7 p.m. on Monday, July 28 at the LaCrosse City Auditorium.
- 10.Entries in the 4-H Division of the Rush County Fair will be judged according to the Danish System of Judging. Based on the discretion of the judge, entries may receive a purple, blue, red or white ribbon.
 - Champion, Reserve Champion, Grand Champion and Reserve Grand Champion placings will be awarded at the discretion of the judge and department guidelines will be followed.

Such classes will be noted. A 4-H member must be 9 years old to exhibit at the Kansas State Fair. All items qualifying for exhibit at the Kansas State Fair must be pre-entered by August 11. All Livestock entries to the Kansas State Fair are due July 15.

4-H LIVESTOCK GENERAL RULES

Superintendent: Robyn Trussel

Awards for Rate of Gain for Beef, Sheep, Swine and Goat donated by Maier Farm Repair

- 1. In order to exhibit at the Rush County Fair, all 4-H market animals must be weighed and tagged by the date designated by the Extension Office for each species. To be eligible for Rate of Gain, animals must be weighed on the scheduled weigh-in day unless prior arrangements have been made. Should the scheduled weigh-in day be cancelled by the District Extension Agent, 4-H'ers must weigh their livestock prior to or on the rescheduled weigh-in date.
- 2. LIVESTOCK WEIGH-IN will be Wednesday, July 30. All beef will weigh in at the LaCrosse Livestock Sale Barn between 11:00 am and 12:00 pm (Noon). All livestock must be in place on the fairgrounds no later than 3:30 pm. Swine, sheep, goats will check-in, weigh-in at the fairgrounds between 2:00 pm and 4:00 pm.
- 3. Livestock, including horses, will be released on Saturday, August 2 at 9:00 pm.
- 4. Exhibitors must furnish feed and water for their livestock entries.
- 5. Each animal must be identified with a stall card.

- 6. Exhibitors are responsible for keeping their animals and pens clean and orderly throughout the fair.
- 7. Any exhibitor who receives three warnings for lack of caring for their animal(s) will be sent home and premiums forfeited.
- 8. Members must show their own animals(s). If a 4-H'er has two animals in the same class, another Rush County 4-H'er must show one of the animals.
- 9. YQCA RULE All livestock members showing breeding or market animals or plan to have animals as part of the Livestock Premium Sale, will need to complete an age appropriate YQCA (Youth for the Quality Care of Animals), class either in person or online <u>before July 1</u> of the current year.
- 10. An animal must receive a blue ribbon to be considered for champion or reserve champion.
- 11. FFA members will show with 4-H members, receive 4-H trophies and ribbons, and receive Fairboard premiums but will not receive premiums from the 4-H Award Fund.
- 12. All livestock must comply with Kansas Department of Agriculture requirements.

4-H LIVESTOCK HERDSMANSHIP

- 1. Herdsmanship Awards: Clubs excelling in both pen cleanliness and club teamwork in the following areas: Beef Barn (will include beef animals, bucket calves, and dairy cattle), Swine Barn, Goat/Sheep Barn, Horse Stalls and Rabbit/Poultry Barn.
- 2. Exhibits will be judged once daily. The purpose of the contest is to provide an incentive to keep the livestock barns presentable at all times to the public. Teamwork is encouraged among members. Everyone's assistance is needed to help make this a fun and fair competition.
- 3. Each livestock exhibitor in beef, dairy, meat goats, swine, sheep, horse, poultry, and rabbits will be assigned a stall or pen for their animals. These will be assigned prior to the fair and grouped according to clubs.
- 4. Winners will be announced each morning at the Livestock Shows. Concession Stand coupons will be handed out to the youth who exhibited in the club/species that wins. Overall Herdsman winner will be announced at the Livestock Sale. and the club will receive the award of \$100.
- 5. Herdsmanship contest will run Wednesday Saturday. Judging times will be unexpected and not at the same time each day.
- 6. Scoring will be based upon the following:

- CLEANLINESS OF ALLEY, STALLS, AND PENS.
 - Bedding adequate, dry, clean and in place. Manure hauled out and deposited in designated areas. Alleyways swept clean, free of dust, sand, wood chips, hay and manure. Watering points and drains kept clean. Feed boxes and gear stored in area provided.
- APPEARANCE OF ANIMALS AND STALL CARDS.
 Animals clean and brushed. Animals securely tied or penned.
- STALL CARDS: Readable from alley. Clean and complete.
- Top clubs in each area will be awarded a certificate each day in each species.
- Totals for the week will be accumulated and prizes will be given by 4-H Council.

RUSH COUNTY PREMIUM AUCTION

- 1. The Rush County Premium Auction committee manages Rush County Fair Auctions which include market beef, market swine, market lambs, market meat goats, meat birds, meat rabbits and food items.
- 2. 4-H/FFA members reserve the ownership of the animal in the premium auction and only receive the proceeds of the premium auction. Any animal identified as a 4-H/FFA project and sold in a premium auction, then sold privately or at another auction, may NOT be shown at any show by the seller or purchaser. The ONLY exception to this is that a 4-H/FFA member may delay butchering until they have shown in the "Champion of Champions" Tri-State Royal in Goodland.
- 3. 4-H members may auction a maximum of three items in a given fair, not to exceed two items per event. Combination may be as follows: two livestock and one food, two food and one livestock, two livestock, or two food. FFA members may auction a maximum of two animals in a given fair.
- 4. Livestock will have to meet minimum weights to qualify for the premium auction. County fair weigh-in weight will be show and sale weight. No re-weighs allowed.

Market Steers 1,000 lbs. Market Swine 200 lbs. Meat Goats 55 lbs. Meat Birds 4.5 lbs.

Market Heifers 950 lbs. Market Sheep 90 lbs. Hair Sheep 55 lbs. Meat Rabbits 3.5 lbs.

5. All market and commercial animals must meet the requirements of the KS Dept. of Ag in order to show and sell. All 4-H/FFA members must show in the species Showmanship contest to be eligible for sale. All market and commercial animals must have been tagged at a Walnut Creek District scheduled weigh-in.

- 6. Members must provide a Rush County Premium Sale and Drug Withdrawal Form at the conclusion of their respective Livestock Show to participate in the sale. All exhibitors must be in good standing with Rush County stipulations.
- 7. Each 4-H/FFA seller will receive a Livestock Buyers Ribbon to present to the purchaser. A 3% commission will be withheld from each animal to cover the cost of the ribbon, postage, and species check-off, and 7% will be withheld from each food item.
- 8. Checks for all market animals will be held until exhibitors have proven to comply with all Rush County Fair rules & thank you notes are verified to the Extension Office. 4-H/FFA members have until the last Wednesday of September to submit documented buyer thank you notes to the Extension office. Premium amounts will be forfeited back to the premium account after that date.

RUSH COUNTY 4-H CARCASS SHOW

- 1. This is totally optional and not a required level of participation.
- 2. The 4-H Carcass Show will replace the ultra-scanning that we have done in the past.
- 3. The 4-H animal that is participating in the carcass show, must have been shown in the current year Rush County Fair in a market class.
- 4. The 4-H animal must have met minimum weight limits set in the specific species rules.
- 5. The carcass will be available for a carcass show viewing on a date to be determined where carcass information and educational opportunities will be shared.
- 6. The carcass show will be only on the animals evaluated at Meade Locker and Processing.
- 7. Each 4-H member will need to complete an Ethical Release and Sale form.
- 8. The carcass show is available for Beef, Sheep, Swine and Meat Goats that showed in their respective market animal class
- 9. Cut Sheets and payment for the carcass will be worked out with Meade Locker and Processing and the 4-H Families.
- 10. Awards will be given for 1^{st} , 2^{nd} , and 3^{rd} place in each species.
- 11. Beef Animals will leave from the Fairgrounds on Saturday Evening and Small Animals will leave from the fairgrounds Monday evening following the fair. Small Animals will not be able to stay on the fairgrounds, they will need to be removed and brought back.

TRIPLE CROWN

- 1. The Triple Crown award will be based on Rate of Gain, Live Show placing and Carcass Show placing.
- 2. The Triple Crown Award will be announced at the Achievement Banquet.
- 3. Triple Crown contest is for the Beef, Sheep, Swine and Meat Goat animals that have shown at the current year Rush County Fair.
- 4. The Triple Crown award will be based off of the 4-H Animal, not the 4-Her, such as the tag number must match in all three areas. All market animals that participate will be given a placing from first to last and the score will be figured on a golf score basis. Example: Rate of Gain—-2nd place, Live Placing—-4th place, Carcass Contest—-1st place, Total Score---7
- **5.** Prizes will be awarded to the Top in each species.

4-H ROUND ROBIN SHOWMANSHIP CONTEST

If one 4-Her has won Grand Champion in more than one species, they will select the species they wish to participate and the Reserve Grand Champion will be invited to participate. Our goal is to have five participants in each age group.

The Grand Champion showman from each species wins the right to show their own animal, the remainder of the five animals will be the animals that placed 1st, 2nd and 3rd in the Junior and Senior Division showmanship classes, in each species, thus having one animal in reserve in the incident that the judge wishes to change out an animal that is being uncooperative.
- 4. Each animal and each 4-Her will be numbered 1 to 5, upon showing the youth will show the animal number that matches with their assigned number. Each 4-Her will wear a back-tag number for identification.
- 5. Animals need to be clean and blown out, ready for show.
- 6. Each Judge will score a 1-10 on each 4-Her, with the points being added together to determine the Division Winners.

All grain exhibits must be cleaned and hand picked. Jars must be one-gallon wide mouth glass jars. For all crops requiring one gallon jar of seed, a cylinder with a diameter of 2 1/2" to 3" may be placed inside the jar to reduce the amount of grain to about three quarts.

Champion and Reserve Champion will be awarded in each section. Grand and Reserve Grand Champion will be awarded overall.

INSTRUCTIONS FOR WEED CONTROL NOTEBOOK

Collect, identify, press, mount, and label a minimum of 15 weeds. Try to include their roots, stems, leaves and flowers. Three of the weeds must be noxious weeds preferably found in your home county. A standard 9"x12" scrapbook may be obtained in which to permanently mount your weed specimens. Identify the scrapbook with your name and county on the inside front cover.

Prepare a list of the weeds mounted, showing common name, scientific name, and where it was found. Place the list in a specially identified section of the scrapbook.

Collect and identify weed seeds found in crop seeds. Mount them for display purposes. Place them in a specially identified section of the scrapbook.

Write a story on "How We Control Weeds on Our Farm" if you live on a farm. Other members write "How We Control

Weeds at Home". The story should be about 300 words in length. It must show definite methods used to control weeds. Place the story in a specially identified section of the scrapbook.

- 2. Secure entry form to disposable plate or container with string or tape. Write name on bottom of plate in case entry card gets detached.

Section 1-GARDEN PRODUCTS

1400 **Small vegetable** specimen plate (12) Ex: green snap beans, yellow wax beans, cherry and pear tomatoes, or other small vegetables.

1401 **Medium vegetable** specimen plate (5) Ex: cucumbers, tomatoes, beets, white onions, yellow onions, red onions, bell peppers, other peppers, okra, parsnips, radishes, turnips, sweet potatoes, red potatoes, white or Russet potatoes, carrots, miniature pumpkin, decorative gourds, garlic or other medium vegetables.

1402 **Large vegetable** specimen plate (1) Ex: watermelon, summer squash, winter squash, large type pumpkin, eggplant, cabbage, cantaloupe, other large vegetable.

1403 **Fresh Culinary herbs** (6) ex: parsley, basil, dill, etc. Six (or a comparable quantity) of one variety of fresh herbs must be exhibited in a disposable container of water. Dried herbs are not accepted.

1404 **Small fruits** (one half pint box) Ex. Strawberries, black-berries, raspberries, or other similar sized fruits. (if other, please include name of fruit on entry).

1405 **Tree fruits** (plate of 5) Ex. apples, pears, peaches, or similar sized fruits.

1406 Grapes (plate of 2 bunches).

1407 **Garden Display**. Each exhibitor in this class will be limited to four square feet of space. The Garden Display must be exhibited in a tray, basket or container that can be easily moved by the fair staff. Exhibit consists of five different types of fresh vegetables or fruits. Canned products and shelled vegetables are not acceptable. Only one variety of each type of vegetable or fruit may be exhibited. The numbers of the five types of vegetables or fruits to be exhibited are as follows:

Large Vegetables (One Each), Medium Vegetables (Five Each), Small Vegetables (Twelve Each), Small fruits (One half pint box), Tree fruits (5 each) or Grapes(2 bunches). See examples of each above class 1400-1406.

Section 2-FLOWERS

Each 4-H'er may enter a total of six (6) items with no more than two (2) per class. Each specimen must be of a different species. **All floral materials must have been grown and**

collected by exhibitor. Do not use purchased plant materials.

Entry shall consist of a notebook or 3-ring binder of written narrative describing a horticulture project such as a landscape design, landscape installation, lawn renovation, water garden, flower garden, vegetable garden, lawn mowing service, landscape maintenance business, farmer's market business or other horticultural project. 4-H members are encouraged to include photographs, illustrations and or landscape drawings that help explain work done by the member. Photos taken from the same location before, during and after the completion of the project are particularly helpful.

Read general rules.

Enter age division according to 4-H age. A 4-H member may enter up to 6 total entries in this department. All baked goods must be left whole and uncut. Small items, such as cookies and rolls, should be the same shape and from the same recipe. See number of items to exhibit below:

<u>A 4-H member may enter up to 6 total entries, being any combination of the following list of suggestions.</u>

*Biscuits, 3 *Commercial Mix, cake, 1, Co fair only

*Cookies, 3 *Cupcakes, 3 or Cake, 1

*Quick Bread, 1 loaf *Yeast Bread, 1 loaf or Rolls, 3

*Decorated Cake or Cupcakes, 3—County Fair only

*Decorated Cookie, 3 *Nutri/special diet Item,

*Gift Package and/or Specialty Food Product

Complete recipes with ingredients and instructions must be attached with the entry, or the placing will be lowered one ribbon when judged.

Baked products should be removed from pans, placed on disposable plates or on covered cardboard cut to fit the size of the product and placed in a clear plastic bag. DO NOT place on styrofoam or wrap in plastic wrap. Entire product must be entered. Unfrosted cakes, except for Bundt cakes, must be exhibited with top crust showing. All frosted cakes shall be entered in cardboard boxes or appropriate, disposable plastic containers.

For food safety purposes, any entries with frostings and fillings must calculate the amount of sugar in the frosting/filling recipe only. The calculation must be attached to entry, or the placing will be lowered one ribbon when judged. Frosting and fillings need to contain more than 65% sugar for safety. Examples on how to calculate this percentage are included in the publication located at: https://bookstore.ksre.ksu.edu/pubs/MF3544.pdf A worksheet is available at: https://bookstore.ksre.ksu.edu/item/frostings-and-fillings-worksheet_4H1171

For food safety purposes, any food with custard and dairy-based fillings and frostings (ex. cream cheese, regardless of sugar content) raw eggs, flavored oils, "canned" bread or cakes in a jar, cut fresh fruit or any food requiring refrigeration (ex. bacon) or unbaked exhibit with raw flour (ex. no bake cookies) will be disqualified and not judged. Refer to K-State Research and Extension publication, 4-H888, Judge's Guide for Food and Nutrition Exhibits, for information to help you make informed, safe food exhibit decisions.

Alcohol (ex. wine, beer and hard liquor) is not allowed as an ingredient in food entries. Entries with alcohol in the recipe will be disqualified and not be judged.

- A Food Gift Package and/or Specialty Food Product must contain at least three different food items(prepared for human consumption), prepared by the 4-H'er, in a suitable container no larger than 18"x18"x 18". This entry will count as a non-perishable food product. All items exhibited within the gift basket must conform to the rules and regulations of the foods division. Additional homemade food items beyond the 3 minimum, or purchased items may also be included in the gift basket. On an attached piece of paper answer these questions: a) what is the intended use; b) what food safety precautions were taken during and after preparation? Prepared food items must have recipes attached with the entry. Herbs, vegetables and garlic in oil are considered perishable. Canning jars should not be used for baking per manufacturer's instructions; they could break during baking.
- 8. Exhibitor may or may not sell their item in the Food Auction. Food Auction will be held on Wednesday, July 30, starting after the Opening Ceremonies (approximately 6 pm). All 4-H food members will need to fill out a food auction label located at the entry table before food judging. All 4-H food members will receive 93% of their proceeds from the food auction. For the members to receive this, they will need to present their food item during the auction. If not able to present food at auction, because of other 4-H judging a member may be involved in, prior notice/arrangements need to be made with 4-H agent. If you are not present and no prior arrangements have been made your proceeds will be defaulted to 4-H Council. Any exhibit that requires 3 items for judging will need to bring 12 items to qualify for the auction.
- A sample of each food item will be placed on display. The entire Grand Champion and Reserve Grand Champion entries will be placed on display unless the 4-H'er prefers to sell the item in the Food Auction.
- A Champion and Reserve Champion will be selected in each level. Grand Champion and Reserve Grand Champion Junior will be selected after combining Level I & II. Grand Champion and Reserve Grand Champion Senior awarded after combining Level III & IV.

No alcohol should be included as an ingredient. Entries with alcohol in the recipe will be disqualified.

Each exhibit must have the complete recipe and instructions attached with the entry card or it will be disqualified. Recipe must include exhibitor name and recipe source, date of publication and altitude where food was processed. If using Mrs. Wage's or Ball mixes, indicate the date of purchased. Recommended recipes and processing methods must be used. *Recipes must be from 1995-present*. Processing methods that will be disqualified include: open kettle canning, oven canning, and sun canning and using electric multi-cookers. If using the Presto Precise ® Digital Pressure Canner, please indicate if the appliance is used for water bath or pressure canning. **Recipes must be adjusted for altitude** based on your processing location, or it will be disqualified. Untested recipes will be disqualified for food safety reasons. There are no safe recommendations to can white peaches or elderberries.

Exhibits must be sealed in clean standard canning jars, with matching brand (use Ball lids on Ball jars, or Kerr lids on Kerr jars, etc.) two-piece lids. Do not use colored jars, padded lids, fabric overlaps or cozies as they interfere with the judging process. No fancy packs unless recipe states to do so (ex. Pickled Asparagus). Jars must be sealed when entered. For food safety reasons, the size of jars used must not be larger than the jar size stated in the recipe. Note: There are 12-ounce, 24-ounce and 28-ounce canning jars available, and may be used. Use pint jar process recommendations for 12 ounce jars. Use quart jar process recommendations for 24-ounce and 28-ounce jars.

Each jar exhibited must be labeled. The label must not cover brand name of jar. The label must give: Class number, product, altitude where processed, canning method (water bath, weighted gauge or dial gauge pressure method), process time, pressure (psi), date processed including month & year, name and county/district. Garments may have been worn but shall be laundered and pressed before being exhibited. Garment may be covered with a clear plastic bag. Each garment should be hung on swivel or wire hangers and must be labeled with exhibitor's name and class number. At least one constructed outfit must be modeled in the Public Fashion Revue to receive premiums. Superintendents may grant exceptions for emergencies at their discretion. Pre-cut kits are acceptable. Exhibits receiving a Purple are eligible for the Kansas State Fair if age 9 or older on Jan 1 of the current year.

Identification Labels - No straight pins may be used to attach these labels. Type or print on a 3"x 2½" piece of cloth or paper: class number, county/district, name and number of pieces in exhibit, (1 of 2, 2 of 2). Sew (or use safety pin) labels on the inside of garment (back of neck,

center back of waistband, or left end of apron band). Label each piece. Place entry card on front left shoulder seam of garment or to the left of waistband with hanger opening facing to the left as if you were wearing the garment.

Recycled Clothing Project - An item made of at least 50% recycled material (recycled means reusing an existing item in a new way). Could be remaking/redesigning a garment, repurposing a clothing item for a new use, etc. Must include sewing of some kind. An index card (no larger than 4"x6") MUST accompany entry describing the recycled materials and how they were used in the item.

Educational exhibits may be a poster, notebook, booth or other display showing and describing something learned in the Sewing & Textile Design project. Maximum size for posters is 22"x28". If the exhibit is a display, maximum size is not to exceed a standard commercial 3' x 4' tri-fold display board. Booths are not eligible for Kansas State Fair.

Department 21 - 4-H Interior Design and Architecture (Home Environment)

Superintendents: Stephanie Maier, Sierra Pechanec

A Champion and Reserve Champion will be awarded in each class. Grand Champion and Reserve Grand Champion will be awarded overall

Classes:

Interior Design Focus:

Interior Designers have a capacity to influence the way we feel when we inhabit a space. In some instances, this impact can be felt emotionally and physically, in other words, it can affect our mood. Tools such as color, light, texture and pattern can all be used to convey or stimulate such a response to a space.

2100 – Interior Room Design Board. Select one room within your home or imaginary/future home (bedroom, bathroom, kitchen, etc.) to design.

Create a basic floor plan showing wall footprint including any furniture, fixture and/or cabinet layout. Include any other illustrations, drawings or photographs to help support your design. Also include material/finish samples (wall treatments, floor covering, paint samples, etc.) Label drawings, material finishes and any additional information so the audience understands their intention. All finishes should be attached to the presentation board along with budget information and design intent. To explain your design intent, write a brief description to be included on the design board. (no more than one page 8.5" x 11")

Presentation boards must be foam core or a standard tri-fold display. Presentation board should be cut to size to fit all drawings, finish materials, images and written materials so it's easily viewed without being oversized. Workmanship, design layout and neatness should be taken into consideration when completing the presentation board.

2101 - Two Collages on Presentation Board. In this project, develop two imaginary interior rooms. Each room should start out with identical dimensions and features (doors, windows, etc.) The function of the room can be up to you (bedroom, coffee shop, art studio, etc.) but should be the same for both rooms. For each space, use collage to create a feeling or mood for the occupants of the space. The mood created for one space should be the opposite or contrast to the second space. Choose a pair of contrasting words from the list provided in the Pilot project materials are located on the Kansas 4-H website under "projects" and "Interior Design & Architecture". Each collage must be on its own page. Maximum page size preference and maximum is 11 x 17; can use smaller dimensions if needed. Collages should utilize layers to convey a space that includes a background, midground and foreground. Once these are established, add as many additional layers as needed. Use print materials from magazines, colored paper, the internet, or other design materials to find furniture, lighting fixtures, textures and other elements to complete each collage. Don't worry too much about the functionality of the space but focus on materials and colors to create the mood of the space.

For each collage, write a brief description of your design intent. (one to three paragraphs total). Additionally, you may include research, inspiration imagery or any additional drawings that helped you design your space.

Adhere to both collages and design intent on a foam core presentation board. Label each collage with the descriptive words you selected from the list.

Foam-core presentation board should be cut to size to fit all collages, images and written material so it's easily viewed without being oversized.

Workmanship, design layout and neatness, and design strategy

should be taken into consideration when completing your presentation board.

2102 – Two Diorama Models. Similar to class 4401, 4-H Members will construct two dioramas, one for each space demonstrating contrasting moods. Each diorama will be designed within similar sized boxes. Boxes should be large enough to be easily viewed but no larger than 12" length x 10" height x 8" depth. Both rooms being depicted need to be the same size. Manipulation to the box is allowed (cutting open such as windows, etc.)

Dioramas should use layers to convey a space which includes a background, midground and foreground. Once you have these established, you can add as many layers as needed. Use print materials from magazines, scrapbook paper, colored paper, the internet or other design materials to find items such as floor, ceiling or wall coverings, furniture, lighting fixtures, textures and other elements to complete each room or diorama. Elements will need to be cut out and adhered to a rigid material such as foam-core board or cardboard and securely placed inside the box to establish each background, midground and foreground to reflect the design of the room.

Don't worry too much about the function of the space, focus on materials and colors to create the mood of the space. Use openings in your container to experiment with the effect of light in your space.

Dioramas should not contain purchased toy figures, miniature furniture/cabinets or moveable parts, but may include securely adhered 3-dimensional elements of the project member's own making. Elements should be adhered to materials easily found at home. For example: magazine photos, cardstock, plastic, cardboard, chipboard or other material to depict design finishes/elements within the diorama.

Include small, foam-core presentation board with the set of dioramas that includes design intent for each diorama and any research or inspiration imagery used to complete the dioramas.

Workmanship, design layout and neatness, and design strategy should be taken into consideration when completing your dioramas.

Architecture Focus:

Architects plan, design and oversee the construction of buildings and other structures beginning with concept development to the final construction phase of projects. It's also important that they ensure the final product is safe and functional. Architects balance artistic creativity with sound building techniques while also considering how the built environment impacts people's emotions and lifestyle.

2103 – Marble Maze or Enclosure. Create a space in which a marble will move through a sequence of rooms, enclosures or spaces. Use different types of elements and materials to enclose your spaces or guide the marble. Consider the size of the marble and how you want the space to feel – big and open or small and enclosed. Pay close attention to the sizes of architectural elements relative to the size of the marble.

To begin, identify a clear goal for the marble maze or enclosure. Use the glossary in the pilot project materials (located at www.Kansas4H.org under projects, then interior Design & Architecture) for design vocabulary to help support the goal. To construct the marble maze or enclosure, use household materials found around the home to create the structure. (cardboard, chipboard, construction paper, paper towel or toilet paper tubes, etc.). Materials don't have to be boring, but they should be functional. Don't be afraid to get creative with

your construction materials when thinking of your overall goal and presentation.

No minimum size requirements for this project, but the base of the structure should be no larger than 18" x 24" (poster board size) and 12" in height.

In addition to your enclosure/maze, you may also present a small design board with illustrations/drawings to help the audience understand the path of travel for the marble, or the rules for which you designed.

Presentation board can be made from foam core or a small tri-fold display. Adhere illustrations, photos or drawings to the board with any other information useful to the viewer including design intent and goals you set for the marble maze/enclosure.

Write or type a brief description of your design intent (1-3 paragraphs total) to be included on the design board. Workmanship, design layout and neatness, and design strategy should be taken into consideration when completing your enclosure.

2104 - Marble Maze Presentation Board Only. Presentation board should be foam-core or tri-fold display with below items attached:

Include drawings of your marble enclosure/maze design; (examples include floor plan, section, elevations, etc.)
In addition to your base drawings, include any illustrations/drawings to help your audience understand the path of travel for the marble. You may also include quality photographs that show the sequence of the marble moving through the built design. Images may be annotated, meaning you can use notes to explain your thoughts/design intent, on the board. This sequence of photos should visually tell the story of your design. Write or type a brief description of your design intent (1-3 paragraphs in total) to be included on the presentation board. Workmanship, design layout and neatness, and design strategy should be taken into consideration when completing your design board.

Department 22- 4-H VISUAL ARTS

Attach a Steps and Instruction Card. All exhibits which need to be hung MUST have a wire or sawtooth hanger attached (no string or tape). Articles exhibited must be an original design created by the exhibitor.

Kansas State Fair – Only one exhibit from each category (fine arts, clay and ceramic, three-dimensional, general crafts) can show on the 4-H level at the Kansas State Fair. Because of this, the county fair judge will choose five (5) total projects for the county to take to the Kansas State Fair. Any 4-H member can show and be judged as an open class entry at the Kansas State Fair. If a 4-H member decides to show their project as an open class entry at the Kansas State Fair, it is their responsibility to turn in an entry form by August 15th, pay entry fees and take and pickup their project at the Kansas State Fairgrounds.

Fine Arts

Oil, chalk, charcoal, dyes, pastels, pencil, ink, acrylic, or watercolor on canvas, canvas board, paper, wood, metal, or textiles, framed as a picture, prepared for hanging. Stretched canvas art on a wooden frame is considered prepared for hanging provided that the frame has a hanger.

Clay and Ceramics

Any original item made of clay; may be fired or unfired, hand formed, or thrown on a wheel. Self-hardening, fire/oven-cured, and/or cornstarch clays are acceptable. Items can include, but are not limited to, clay statues, bowls, etc.

Leather and Jewelry

Any leather stamping, carving, tooling, lacing, or stitching piece or any jewelry piece made from any medium are acceptable exhibits.

Three-Dimensional

The piece must be observable on at least three sides and should be either free-standing or prepared to be hung. Craft and pre-formed or assembled projects are not acceptable.

General Crafts

This category incorporates miscellaneous pieces that do not correspond to the four, above-mentioned categories.

Anything made from a kit is not eligible for state fair selection.

A 4-H member may enter up to 6 total entries.

A Champion and Reserve Champion will be selected in each level. A Junior Grand Champion and Reserve Grand Champion will be selected for Levels 1 & 2 combined. A Senior Grand Champion and Reserve Grand Champion will be selected for from Levels 3 & 4 combined.

Department 23 - 4-H FIBER ARTS

Superintendent: Heather Ross & Brittany Peteler Junior Superintendent: Emily George, Rylie Larson, Macy Smith

A Fiber Art is any method of creating a unique design with fiber, fabric, felt or yarn. This may include making fabric such as weaving, crocheting, knitting or needlepoint. This may also include changing existing fabric into something quite different such as quilting, embroidery or ethnic art. Ethnic fiber arts should use a fiber, yarn or fabric to create the design exhibit. Non-textile (examples include wood reed, straw, grass, etc.) baskets/pieces should be entered in the Visual Arts Division. Ethnic fiber arts also can do felted items that are not Knitted or Crochet, etc.

Print or type exhibitor's name, county and class number on a 3"x2 ½" piece of cloth. Attach label with thread or safety pins to all items. Explain whether you hand knitted the fabric or used a knitting machine. Also, indicate if the exhibit contains any recycled materials or is made of at least 90% wool. If the item is an original design, note this fact on the 4"x 6" card. For quilted items indicate who did the quilting and binding.

Articles normally worn together as a pair must be shown together. Securely fasten articles together with yarn. To be displayed, exhibits which need to be hung must have an appropriate hanger, rod, wire or other mechanism attached.

The exhibitor must determine the class in which a constructed item that includes one or more Fiber Arts techniques will be entered. Such an item may only be entered in one department.

Grand Champion and Reserve Grand Champion Junior will be named. Grand Champion and Reserve Grand Champion Senior will be named.

Age Divisions are as follows:

Section 1- Fiber Arts Exhibit

Crochet, any article, including felted items. Class 2300 **Junior** Class 2301 **Senior**

Knitting, any article made either by hand or by knitting machine including felted items.

Needle Arts, any article created by hand using any of the following techniques: Embroidery and cross-stitch, Needlepoint, Candle wicking, Crewel, Lacework, Appliqué. Class 2304 Junior Class 2305 Senior

Patchwork or Quilted article - It is acceptable practices for the exhibitor to create the patchwork or quilted article and have someone else quilt it.

Class 2306 Junior Class 2307 Senior

Rug Making, any rug - acceptable techniques include braiding, latch hook, tying, floor cloth, etc. The finished product should be an item that would be an item used in the home. Class 2308 **Junior** Class 2309 **Senior**

Spinning, a skein - minimum 10 yards in length Class 2310 **Junior** Class 2311 **Senior**

Weaving, any woven article - Members should attach information about the type of loom or process used.

Class 2312 Junior Class 2313 Senior

Ethnic Arts, any article: This is defined as a Fiber Art/Textile technique that is associated with a specific country or culture. It is a practical skill that was developed to provide basic family needs such as apparel, home furnishings or decorations. It is also defined as a method that has been maintained throughout history and passed on to others, often by observation and by example, such as batik, Swedish huck towel weaving, mud cloth, bobbin weaving, tatting, felted items that are not knitted or crocheted, etc. Members should attach information on the history of the ethnic fiber art, where it was used, by whom, how it was used, short description of the technique, etc.

Fiber Arts Educational Notebook, The notebook or binder should include a narrative section describing the fiber art. It should include a clear description of the project, technique, budget, supplies, goals, accomplishments, successes, failures and the future plans. It may include samples of techniques, how-to's, photographs of completed projects, or other ways of

educating others about fiber arts. NOTE: a collection of brochures, webpages, patterns, record book forms, etc. does not constitute an educational notebook. Follow copyright laws. Name, local unit, and fiber art covered must be clearly marked in the notebook.

Section 1-BOOTHS Class 2400 Club Booth

Class 2401 Individual /Group Booth

Booth size is approximately bottom 4'x4', back 4'x6', sides 4'x4'. Each club or exhibitor is limited to one booth. Each booth must be labeled with a sign with club name approximately 4"x16". Premium money will be forfeited if booths are not properly cared for. Booth walls must be covered.

Section 2-BANNERS

Class 2405 Club Banner

Banners should illustrate a phase of 4-H work being practiced by youth in 4-H or promote 4-H generally. 4-H exhibitors should avoid using copyrighted materials whenever possible by originating their own work. Copyrighted and/or trademarked materials utilized in banners for endorsement or promotion instead of educational purposes will be disqualified and will not be displayed. Banners are a 2 dimensional display depicting one idea. Dimensions are to be no less than 12 and no more than 16 square feet, with no side less than 3 feet. Banners must be hung on a rod strong enough to support the banner. Banners should be made of materials that permit the banner to be folded or rolled without damaging the display. Objects may not be attached to the front of the banner. Attach a label to the front lower left-hand (as you face it) corner of the banner giving the name of the club and county or district. Each club may enter one banner.

Section 3-CLUB POSTER

Class 2410 **Club Overview Poster** Should reflect club projects of the current 4-H year. Maximum size of 22" x 28". Should include pictures and captions explaining the project. Newspaper clippings may be used.

Department 25 - 4-H ENTOMOLOGY

All entries are to be placed in **Plexiglas** covered wooden boxes with outside measurements of $18" \times 24" \times 3\frac{1}{2}"$.

Display boxes with glass covers WILL NOT be accepted. See the specific phase for box and specimen number limitations.

4-Her's may choose to use one of two taxonomies:

A. Option A: As printed in "Insects in Kansas" book or

B. As printed in the "Insects in Kansas Book: 2016 Revised Taxonomy", which follows www.bugguide.net

Resources for exhibiting can be found on the Kansas 4-H Entomology project page.

Each exhibitor is required to identify each box with two identification label bearing: Exhibitor's name, county or district, the class and statement of taxonomy used. One label goes in the upper left corner of the box (inside) and the other on the lower right corner of the box (outside). Arrange specimens in the box so it can be displayed lengthwise. The number of orders, specimens (and families where required) must be included on both the exhibitor's box identification label.

Only one adult insect per species can be used in the Collection Boxes and Notebook Classes, unless labeled as male or female and correctly identified

Arrangement of specimens:

Arrange specimens in groups or rows parallel to the short sides of the box. Specimens are to be arranged in the box according to Order, then Family where required.

Two labels should be centered on the pin beneath each specimen. First (closest to the specimen) is the common name label and the second label should include date, locality, full county name, state abbreviation should be on the second label. Collectors name or host on the date/locality label is optional.

The specimens should be collected by the exhibitor and should focus on Kansas insects. Insects may be collected from one county into bordering states and labeled accordingly. Please refer to "Entomology Collection Exhibit Resource" for full details on out-of-state insects in collections. Only specimens of the class Insecta should be included.

Purchased insects are not to be exhibited in collections, but they may be used in educational displays.

Specimens of soft bodied insects such as aphids, lice, termites and etc. should be exhibited in alcohol filled vials, however, the use of alcohol filled vials should be limited to only those specimens that lose their shape when pinned, since the vials pose a significant hazard to the rest of the collection if they become loose in transit.

Grand Champion and Reserve Grand Champion awarded overall.

Section 1- ENTOMOLOGY

Class 2500 **Introductory Entomology** (not eligible for the Kansas State Fair). Minimum specimens, 15. Maximum specimens 30. Minimum orders. 6.

Open to those in their first two years of entomology. Specimens must be exhibited in small cardboard or plastic boxes (One or two boxes with a total display area no more than 130 square inches). Boxes can be homemade by placing a layer of polystyrene foam in the bottom of a shoebox, school box, or

storage container or can be purchased from a biological supply company. For the exhibit, the boxes should be covered with a clear plastic wrap or acrylic glass taped across the top of the box. Insect names are not required however, datelocality labels are required for each specimen. Order labels must be pinned to the bottom of boxes.

Class 2501 BEGINNING ENTOMOLOGY Collection 1

Display in one standard box a minimum of 50 and maximum of 125 species representing at least 7 orders. Follow the guidelines listed for all collections.

Specimens should be grouped according to order with the order labels pinned to the base of the box. Members can exhibit in this class a maximum of 3 years or until they receive a purple ribbon at the Kansas State Fair, whichever comes first.

Class 2502 BEGINNING ENTOMOLOGY Collection 2

Display in one standard box a minimum of 75 and maximum of 150 species representing at least 9 orders. Specimens should be grouped according to order with the order labels pinned to the base of the box. Members can exhibit in the class a maximum of 3 years, or until they receive a purple ribbon at the Kansas State Fair, whichever comes first.

Class 2503 INTERMEDIATE ENTOMOLOGY Collection

Display a minimum of 100 and a maximum of 300 insects representing at least 10 orders. Two standard boxes can be used. All specimens should be grouped to order. In addition, family identification is required for all insects in any two of the following six orders: (Only two will be counted for judging)

A. "Insects in Kansas" book - Orthoptera, Hempitera, Homoptera, Coleoptera, Hymenoptera, and/or Diptera *or* B. "Insects in Kansas Book: 2016 Revised Taxonomy", which follows www.bugguide.net - Odonata, Orthoptera, Hemiptera, Coleoptera, Hymenoptera, and/or Diptera.

On a piece of paper list what you did to improve your collection during the current year. Members can exhibit in this class a maximum of 3 years. A 4-H'er will move up if they receive a purple ribbon at the Kansas State Fair.

Class 2504 ADVANCED ENTOMOLOGY Collection

Display a minimum of 150 and a maximum of 450 insects representing at least 12 orders. Three standard boxes can be used. Follow the general guidelines listed for collections. Family identification is required for all insects belonging to the six basic orders as outlined under the Intermediate phase. Only families in the above six orders will be counted for judging. Family identification of insects in the remaining orders is optional, but desirable as long as accuracy is maintained. On a piece of paper list what you did to improve your collection during the current year. Examples: what insects did you add or replace; what orders and/or families you added; what Leadership you provided in this project; and/or what insects you have studied. Attach paper to the back of one of the display boxes. Members may continue to exhibit in this class at the Kansas State Fair for an unrestricted number of years as long as they remain eligible for 4-H membership.

NOTE: Any major violations of rules will result in the exhibit being dropped one ribbon placing.

ENTOMOLOGY NOTEBOOK

- Individual entries are to be placed for display in a three-ring notebook for competition.
- 2.4-H'ers may choose to use one of two taxonomies:
 - A. As printed in "Insects in Kansas: book or
 - B. As printed in the "Insects in Kansas Book: 2016 Revised Taxonomy", which follows www.bugguide.net
- 3. 4-H'ers who have been previously enrolled in or are currently enrolled in the other phases of the Entomology project need to start with the Beginning Phase of Entomology Notebooks, not the Introductory phase.
- 4. Each exhibitor is required to identify the notebook by placing a Title Page in the front of the notebook bearing the ex-

- hibitor's name, county or district and class 4-H'er is enrolled in and statement of taxonomy used in options "A" or "B". The number of orders, specimens and families (required in Intermediate and Advanced classes) must also be included on the Title Page.
- Specimen pages should be grouped according to order and should include one page per species. If more than one insect is in the photo, an arrow to indicate identified insect should be used.
- 6. Date, common name, full county name, state abbreviation and collector name should be included for each species. Collector's name on the specimen page is optional.
- 7. Specimen pages should have two different views of the insect if possible. If pictures are taken on different dates/localities, include information for both.
- 8. A statement describing the habitat where found/host plant may be included and is encouraged and will be worth a bonus 10 points total, not per page. For Intermediate and Advanced notebooks, this is strongly encouraged.
- 9. A divider page is to be placed in front of each order of insects with the order name printed on the tab for the page and also on the front of the divider page.
- 10. For the Intermediate and Advanced classes, insects are also to be grouped by family behind each order divider. If the exhibitor has been in the same class for more than one year, a separate sheet of paper needs to be added stating how many years the exhibitor has been in this class of the project and what the exhibitor did his year to improve their notebook. Place the paper just behind the Title Page in the front of the notebook.
- 11.A special project must be completed each year and included in the notebook. See project guideline materials for specifications.
- 12.Refer to the publication "Entomology Collection Notebook Guidelines" on the Kansas 4-H Entomology web page for more detailed rules for exhibiting.

Section 2-ENTOMOLOGY NOTEBOOK

Class 2508 Introductory Notebook

Display in one 3-ring notebook a collection of photos with a minimum of 10 and a maximum of 30 insect species representing at least six different orders. Follow the general guidelines listed for notebooks, including the Special Project. A 4-H member must be of minimum age to compete at the Kansas State Fair. A 4-H'er may exhibit in this class for a maximum of two years.

Class 2509 **Beginning Notebook**

Display in one 3-ring notebook a minimum of 20 and a maximum of 60 insect species presenting at least seven different orders. Follow the general guidelines listed for notebooks, including the Special Project. Members can exhibit in this class a maximum of 3 years or until they receive a purple ribbon at the Kansas State Fair, whichever comes first.

Class 2510 Intermediate Notebook

Display in one 3-ring notebook a minimum of 60 and a maximum of 100 insect species representing at least nine orders. Follow the general guidelines listed for Notebooks, including the Special Project. In addition, family identification is required for all insects in any two of the following six orders: (Only two will be counted for judging):

A. "Insects in Kansas" book - Orthoptera, Hempitera, Homoptera, Coleoptera, Hymenoptera, and/or Diptera or

B. "Insects in Kansas Book: 2016 Revised Taxonomy", which follows www.bugguide.net - Odonata, Orthoptera, Hemiptera, Coleoptera, Hymenoptera, and/or Diptera. A 4-H'er may exhibit in this class for a maximum of three years.

Class 2511 Advanced Notebook

Display in one 3-ring notebook a minimum of 100 and a maximum of 200 species representing at least twelve orders. Follow the general guidelines listed for Notebooks, including the Special Project. In addition, family identification is

required for all insects belonging to the six basic orders as outlined under the Intermediate phase. Only families in the above six orders will be counted for judging. Family identification of insects in the remaining orders is optional, but desirable as long as accuracy is maintained. Members may continue to exhibit in this class for an unrestricted number of years as long as they remain eligible for 4-H membership.

Section 3-EDUCATIONAL DISPLAY

Share with others what you have learned in this project. Exhibit any activity or learning experience related to the field of entomology or the Teaming with Insects curriculum that does not fit into Entomology collection or notebook classes above. Follow copyright laws as explained in the General Rules.

- The exhibit may be, but isn't limited to, original works, digital presentations (must provide printed hardcopy of exhibit purposes for the duration of state fair), programs, websites, games, apps, display box, notebook, display or poster which you have made.
- If the exhibit is a wooden display box, it must be 18"x24"x3.5" with a clear plastic top (such as plexiglass) and displayed horizontally. If the exhibit is a poster, it must not be larger than 22"x28". If the exhibit is a display, maximum size is not to exceed a standard commercial 3'x4' trifold display board. Name and county/district must clearly be marked on educational exhibits on the front left hand side.

Class 2512 Beginning Educational Display

Class for individuals that are exhibiting in the Beginning I and II Collection or Beginning Notebook Classes. If only exhibiting in this category, then ages 9-12. Follow the general rules listed for the Educational Displays.

Class 2513 Intermediate Educational Display

Class for individuals that are exhibiting in the Intermediate Collection or Intermediate Notebook Classes. If only exhibiting in this category, then ages 11-14. Follow the general rules listed for the Educational Displays.

Class 2514 Advanced Educational Display

Department 26 - 4-H Woodworking

- 1. The plan from which it was constructed MUST be with the article exhibited. The plan may be a photocopy, the actual pattern, or a scale drawing. It must be complete and accurate to the extent that a duplicate article could be built using the plan as a guide. Please note: A set of step-to-step instructions is not a plan.
- 2. Projects with missing or insufficient plans will be lowered one ribbon placing (i.e. a blue ribbon exhibit will receive a red ribbon).
- 3. Projects that have unsecured glass, i.e., glass shelves, glass top of a coffee table, etc., should not be brought to the fair. Glass that is secured in the project, i.e., glass front of a gun case or cabinet, etc., is permissible since it cannot be easily removed. The use of materials used, other than wood, should be kept to a minimum.
- 4. The entry card, plans and all other paperwork should be enclosed in a zip top plastic bag with a hole punched through it and using string to tie this to the exhibit. Tape is not an adequate way to attach the bag to the exhibit.

- 5. In the judging of woodwork articles, consideration will be given to: Workmanship, including accuracy to the plan; Design; Choice of wood, Suitability and quality of finish; and Usefulness.
- Refinished/repaired furniture should be exhibited in the Interior Design-Architecture Department in class—single exhibit.
- 7. Firearms and weapons are not to be entered or exhibited at the Kansas State Fair.

Department 27 - 4-H Technology and Engineering (formerly STEM)

For all current Space Tech rules and regulation refer to the Supplemental version of Technology and Engineering rules, ask the extension office for a copy.

The 4-H member must be currently enrolled in the 4-H Space Tech project to exhibit in this division. Each exhibitor may enter one exhibit per class. Exhibit must have been completed during the current 4-H year.

All work in construction, paint, display, must be completed by the 4-H member, with adult supervision when needed.

If a safety violation is noted by the judges, superintendents or extension staff, the exhibitor's exhibit will be given a participation ribbon.

Educational Exhibits Rules

- 1. For notebooks, display boards, and posters, no additional exhibit information is required; no manila envelope is needed for these exhibits.
- 2. Exhibits are to have a **clear link to the Engineering and Technology areas** of ag-mechanics, BBE, astronomy, computers, rocketry, robotics, or Un-crewed aerial systems. Educational exhibits outside of these Engineering and Technology areas should be displayed in the other program areas. Just because an educational exhibit relates to the broad concept of Engineering and Technology does not qualify it to be displayed in the Engineering and Technology Educational Exhibit area. Exhibits that do not clearly show a clear and direct relationship to the Engineering and Technology project areas of ag-mechanics, BBE, astronomy, computers, robotics, rocketry, or UAS as previously defined will be disqualified.
- 3. Exhibits in posters, notebooks and display boards must contain substantial supporting educational materials.
- 4. Educational display boards, posters and notebooks should be creative and showcase details about the knowledge learned in the project during the current 4-H year. Value is placed on youth who can demonstrate how their skills have increased while completing the project. Each exhibit will be judged on uniqueness, creativity, neatness, accuracy of material, knowledge gained, and content. For example, a rocket that may have crashed and/or is highly damaged may be made into an educational display or poster that tells a great story with many lessons learned.
- 5. Follow copyright laws, citing all sources of information in a standard notation. Sources of information must be cited on the front of your exhibit, including all posters and educational display boards.
- 6. Educational displays are not to exceed a standard commercial 3' x 4' tri-fold display board. No card table exhibits will be allowed. Care should be taken to use durable materials that will withstand fair conditions.
- 7. "Construction Kits" that are part of Educational displays must be contained in cases (tackle boxes, sealable containers, etc.) that may not be larger than $1' \times 2' \times 2'$ and must have a latch which securely keeps all components contained in the "Construction Kits". Other components are to adhere to appropriate dimensions as stated elsewhere.
- 8. Educational Project notebooks must be organized in a 3-ring binder.
- 9. Any three-dimensional poster or display board exhibits may not be thicker than 2 inches.
- 10. Engines and igniters for rockets ARE NOT permitted with the exhibit and constitute an immediate disqualification. This is for safety reasons and includes both spent and live engines. 11. Exhibitor's name, Extension Unit, age, and year(s) in project must be tagged or labeled in a prominent location on the notebook, and/or "Construction Kit." For education displays and/or posters the exhibitor's name, county, or district, age, and year(s) in project must be tagged or labeled on the back of the exhibit. Failure to label an exhibit may result in one ribbon placing deduction.
- 12. Exhibits should possess the following qualities (in no particular order):
- a. A Central theme
- b. What you want others to learn

- c. Be designed and constructed in a manner befitting the exhibit
- d. Be something you are interested in
- e. Be related to Ag Mechanics, BBE, Astronomy, Computer System, Robotics, Rocketry, or Un-crewed Aerial Systems 13. If a safety violation is noted by the judges, superintendent, or other staff, the exhibitor's exhibit, at the judge's discretion, will receive a participation ribbon.

Champion and Reserve Champion will be awarded in each section for both junior and senior age level.

Department 28 - 4-H ELECTRIC AND RENEWABLE ENERGY (Energy Management/Electronics/Small Engine/Wind Power)

Superintendent: Mark Goodheart Junior Superintendent: Travis Ross

Articles that have been in use should be cleaned for exhibit. Each exhibit must include a "4-H Electronics & Renewable Energy Information form which is available at http://electric.engtech4KS.com/ This form must be attached to the outside of a 10 X 13" manila envelope. Youth must include and place in the manila envelope a wiring diagram or schematic. A sheet of operating instructions must be furnished and included in the manila envelope for any exhibit not self explanatory. No manila envelope is needed for notebooks, display boards and posters.

Exhibit must be operable using only 110 or 120V AC or battery power. If battery power is required, batteries must be furnished. Any project with a complexity of size or electronics must have (a) instructions for assembly and use and (b) equipment available at the time of judging for actual testing of the exhibit. No hand dipped solder may be used in exhibits.

Each 4-Her may enter a total of six (6) items with no more than two (2) per class.

Champion and Reserve Champion will be awarded in each section. Grand Champion and Reserve Grand Champion will be awarded overall.

JUNIOR, 7-12 years of age SENIOR, 13-18 years of age

Section 1-Electrical and Electronics

Class 2800 **AC Electric Projects** - Electric projects with a 110 or 120 V alternating current (AC) power source. Some project examples are household wiring demonstrations, small appliances extension cords, trouble light, indoor or outdoor wiring boards, or shop lights. Projects may be a restoration or original construction. The project must be operational and meet minimum safety standards. AC projects must be 110/120 V, no 240V exhibits are allowed, and must be constructed such that the judges have wiring access to examine the quality and safety of workmanship.

Class 2801 **DC Electric Projects** - Electric projects with a battery or direct current power source. This class includes electric kits or original projects. This class also includes demonstration DC powered projects. Examples include: wiring two or three way switches, difference between series/parallel lighting circuits or wiring doorbells switches. All DC electric projects must include batteries supplied by 4-Her. Projects must be constructed such that the judges have access to examine the quality of wiring workmanship.

Class 2802 **Electronic Projects** - Electronic projects with a battery or direct current power source. This class includes electronic kits or original projects. Examples include radios, telephones, toy robots, light meter, security systems, etc. May be constructed using printed circuit board, wire wrap or breadboard techniques. Include instruction/assembly manual if from a kit. Include plans if

- an original project. Projects must be constructed such that the judges have access to examine the quality of wiring workmanship.
- New—Newly built or repaired computers. This class is for newly built or repaired computers (laptop or PC) and allows 4-H members to demonstrate skills integrating the various parts of a computer into a single unit. Displays should show either a fully functional computer or show what the individual components do. The display should be free of dust and cabled neatly. Fully functional computers should boot up and do not need to include a monitor, keyboard, or mouse at the State Fair.
- Class 2803 **Educational Displays and Exhibits** -This class includes any educational displays, exhibits or science fair projects that DO NOT have a power source. i.e. exhibits, posters or displays of wire types, conduit types, electrical safety, tool or motor parts identification or electrical terminology. Educational displays must be legible from a distance of four feet using a maximum tri-fold size of 3'x4'.

Section 2-Alternative Energy (a form of energy derived from a natural source, such as the sun, geothermal wind, tides or waves.)

- All exhibits in this division are limited in size to standard, trifold, display boards (36"x48") and items may not extend beyond 12" from the back board, all displays must be self standing.
- Class 2807 **Educational Display** Create an exhibit that addresses a focused topic related to power generated from a renewable energy source. The purpose of the exhibit is to inform and create awareness.
- Class 2808 **Experiment** Display an experiment addressing a problem or question related to power generated from a renewable energy source. Include hypotheses, background research, variables, a control, data, findings, conclusions and recommendations for future study.

Department 29- 4-H SMALL ENGINES

Items that have been in use should be cleaned for exhibit. Each exhibit must include a "4-H Electronics & Renewable Energy Information form which is available at http:// smallengines/engtechchrks.com/ This form must be at-

tached to the outside of a 10 X 13" manila envelope. A sheet of operating instructions must be included in the packet for any exhibit that is not self-explanatory.

Section 1-Small Engines

- All exhibits should involve engines smaller than 20 horsepower. Engine should contain no fuel in tank or carburetor.
- Class 2804 **Display** Exhibit a display, selecting one of the following options: 1)a display identifying different engine or lawn and garden equipment parts or a display showing the function of the various engine or a display showing the function of the various engine or lawn and garden equipment parts; OR 2)a display identifying and explaining the function(s) of different special tools needed for small engine work; OR 3)a display illustrating and providing the result of any one of experiments that are included in the project books. No complete engines, lawn tractors, tillers, chainsaws are permitted for display. Maximum tri-fold size is 3'x4'.

- Class 2805 **Maintenance** Exhibit a display that illustrated either: 1)routine maintenance procedures OR 2)diagnosing and troubleshooting specific problems in an engine. No complete engines, lawn tractors, tillers, chainsaws, etc. are permitted for display using a maximum tri-fold size of 3'x4'.
- Class 2806 **Operation** Exhibit an operable small engine (no more that 20 HP) overhauled or rebuilt by the member. Include maintenance schedule for the engine and a brief description of steps taken by the member overhauling or rebuilding the engine. Engine should contain no fuel in tank or carburetor.

Department 30- 4-H PHOTOGRAPHY

Superintendents: LeAnn Keener, Joyce Cornwell Junior Superintendents: Ashlynn Hoover, Ally Lineberry, Hope Lumpkins, Josie Larson, Aiden Ochs-Lohrey, Maryn Ochs-Lohrey


Photo images must be taken by the 4-H member. <u>Each 4-H'er</u> may enter a total of six (6) items with no more than three (3) per class.

- Black & white prints and color photographic prints may be exhibited. Any format of camera may be used, but phone cameras are not recommended. Remove white borders from the photo print before mounting. Photos must be no larger than $8" \times 10"$ and no smaller than $7" \times 9"$ after trimming.
- Photographs taken with a digital camera and having no more adjustments than exposure, color intensity or correction, one click filter effects, red eye removal, cropping, dodging and burning should be entered in the standard color or black and white classes. HDR photos are to be entered in the standard photo class.
- The black and white class is for black and white prints only. Monochromatic prints, including sepia prints are considered color photos and must be entered in the appropriate color photo class.
- Appropriate photo subject matter: Photogenic subject matter is expected to follow 4-H standards. For a sense of photographic subject matter, review the Kansas 4-H member Code of Conduct; in general, if it is not allowable at a 4-H event, it is not allowable in a 4-H Photograph at the Kansas State Fair.

Photos with live subject(s) on railroad right-of-way or taken from railroad right-of-way property will not be displayed in Kansas 4-H Photography and will be disqualified and not judged.

- A full coverage permanent photography mount must be made (spray adhesive recommended or heat mount). Do not use double stick tape, rubber cement or other household glues. These products cause buckling, stains or lumps in photo surfaces. Frames and glass are prohibited. No lettering is permitted on the front of the photo. (Dates are considered to be lettering.)
- ALL (both horizontal and vertical) photos must be <u>permanently mounted across the NARROW (11") dimension of an 11" x 12.5" sheet of white studio matte board.</u> Do not use foam core board or poster board. Matt boards may be purchased from your local K-State Research and Exten-

sion Office. Photos must be mounted with the top edge of the print 1" below the top of the mount board (the board is always oriented narrow side up). The sides of the print should be equal distance from the sides of the mount (centered).



Improperly mounted photos, oversize or undersize photos or photos with the white borders not removed or lettering on the photo will be awarded a ribbon one place lower than the placing determined by the official judges.

Each mounted 4-H photography entry must be displayed in clear photo sleeves that can be purchased at the Extension Office. When inserting your photo into the sleeve, the opening flap should be at the bottom of your photo. Do NOT seal the plastic flap. At the Rush County Fair, each entry must have a completed entry tag inside the clear photo sleeve.

On the back of the mount, write: Exhibitor Name, photo class and WCED/Rush.

STATE FAIR ELIGIBILITY- A photograph entry must receive a purple ribbon at the Rush County Fair to qualify for exhibit at the Kansas State Fair. An exhibitor must be 9 years of age but not yet 19 years of age on January 1, 2025 to exhibit at the 2025 Kansas State Fair. Exhibitors, first through seventh year, in the project may enter ONE photo per exhibitor at KSF.

mount board or foam core board not larger than $16" \times 20"$. Photo essays may be vertical or horizontal. A title or headline may be included and it should be neatly printed. Adhesive letters may be used. Other rules apply to the Photo Essay except as specifically noted.

Member is eligible for this class **beginning with the third year** of enrollment in the 4-H Photography project.

Exhibit will consist of one photo for each year of enrollment. Each photo must have been created in a different year and must be labeled with year taken/project enrollment year. A maximum of 5 photos may be included if the member has 5 or more years of enrollment. Photos are not required to be in a consecutive order. For example, a nine-year-old with three years enrollment in photography is eligible to enter a growth portfolio. The portfolio in this example should have one photo from the sevenyear-old year, one photo from the eight-year-old year and one photo from the nine-year-old year. The growth portfolio class may start at any time in the member's photography career. For an older member, the growth portfolio would represent any five years in the project, for example, years 1,3,5,7, and 9 for a member having project enrollment totaling 9 years.

Photos must be 8" x 10" and may be color or black and white and must be unmounted. An information sheet must accompany each photo giving brand and model of camera used to create the photo. The settings for focal length, aperture, mode and shutter speed must also be listed. The skills used to create the photo must be given and fully explained. The main goal for each year should also be given. This form may be downloaded from kansas4h.org website; it is form fillable and is required.

A short introduction of the photographer should be placed on the first page. This introduction should tell why the 4-H member enrolled in the photography project and why they have continued to enroll. Exhibitor could also tell of a fun event photographed, a learning experience that taught them new skills or other related learning.

Beginning with photo 2 (two), member description of GROWTH in project skill must be included on information sheet. Exhibit will consist of introductory page, skill sheet and photo from each year in chronological order and arranged in a portfolio book. Skill sheet will go in left hand page and unmounted photos in right hand page.

Career Portfolio

Member must have been **enrolled in Photography for 5 (five) or more years** OR member must be age 15 -19 and been enrolled in photography for at least two (2) years.

Exhibit will consist of ten (10) 8 x 10 photos showing skill development in one of the following photography areas: Portraiture, Special Effects (not done with computer), Landscape, Photo Journalism, Black and White, Nature/

Wildlife or Graphic Design (computer skills with photos). All photos must be the result of the current 4-H enrollment year. Photos may be color except if Black and White option is chosen and must be unmounted.

An information sheet must accompany each photo giving brand and model of camera used to create the photo. The settings for focal length, aperture, mode and shutter speed must also be listed. This form may be downloaded from kansas4h.org; it is form fillable and is required.

A one page summary should accompany the portfolio, listing the goal for pursuing this area of photography and what skills were learned while doing so. Mentors should be acknowledged. Career exploration can also be described.

Exhibit will be presented in a notebook designed for portfolio review with pages for required information from above.

Class 2907 – My Favorite 4-H Photography Display

This is a display only class. **Eligible members must have** been in photography for ten (10) or more years.

Choose a total of four(4) of your favorite photos from any of the years enrolled in photography. If used previously in competitive exhibits, remove all data slips and stickers. If the photo is unmounted print, mount it using standard 4-H requirements and mat board.

Develop a short biography piece. Include a small (2 x 3) photo of yourself at the start of the biography. Tell how/when an interest in photography began. Explain why each of the four photos is a favorite. Share the skills learned because of photography. Think beyond the camera skills and include leadership, community service, etc. Tell of any mentors/ leaders worked with. Share workshops or camps pertaining to photography you attended. Explain (if relevant) any plans to use photography skills beyond 4-H/High School. Print the biography document and mount it on a standard mat board. This exhibit does not have to qualify at the county/district level to exhibit at the Kansas State Fair.

Department 31 - 4-H DISPLAYS, NOTEBOOKS & POSTERS

Superintendents: Janelle Maier, Amanda Smith Junior Superintendent: Allie Smith This department is not eligible for the Kansas State Fair.

Display areas must be reserved by July 15 if a large area is needed. Display areas are 4'x4' or less. Two posters may be entered per project. If the exhibit is a poster it must not be larger that 22"x28". If exhibit is a display, maximum size is a 3'x4' trifold display board.

Displays, notebooks and posters in the following projects must enter under the corresponding department: Clothing, Electric/Renewable Energy, Entomology, Foods, Geology, Shooting Sports, Aerospace/Rocketry, Astronomy, Building Block Engineering, Computer Science, Robotics, Uncrewed Aerial Systems, Photography, and Wildlife.

Champion and Reserve Champion will be awarded in each section. Grand Champion and Reserve Grand Champion will be awarded to the overall Department with all section champions combined.

Stopping Power-15 points - Is the main idea specific? Is the idea presented clearly, simply, forcefully?

Interest & Holding Power-15 points - Does the exhibit give the observer additional facts in a clear, concise, informative way?

Mechanical Power-5 points - Correct letter size, pleasing color combination, appropriate symbols and models?

Personal Growth-25 points - How much knowledge was gained by exhibitor? Enthusiasm shown?

Educational Value-25 points - Knowledge shared?

Types of exhibits in this department are open to educational or creative displays, educational posters or notebooks.

Take care to select durable materials to withstand fair conditions. No card table exhibits are allowed. If the exhibit is a poster, it must not be larger than 22"x28". If the exhibit is a display, maximum size is 3'x4' trifold display board.

EXHIBITORS MUST COMPLY WITH STATE AND FEDERAL LAWS. It is illegal to possess threatened or endangered wildlife or the feathers, nests or eggs of non- game birds. Game birds and game animals taken legally during an open season may be used. The use of live wild animals is prohibited.

Name, county, age and year in project should be in a prominent location on the exhibit.

Notebooks and Educational Displays will be judged on the following criteria:

Stopping Power- 15 points - Is the main idea specific? Is the idea presented clearly, simply, forcefully?

Interest & holding Power- 15 points - Does the exhibit give the observer additional facts in a clear, concise, informative way?

Class 3100 **Notebook** Contents pertain to some phase, results, story or information about the wildlife project.

Class 3101 **Promotional Poster** Must be related to something learned in the wildlife project. Flat poster board or foam board no larger than 22"x28".

Class 3102 **Educational Display** Must be directly related to the wildlife project. Maximum tri-fold size is 3'x4'.

Experiential/Other Classes

3105 Fish Harvesting Equipment - (SF168) - Board exhibit. Display of equipment used in fish harvesting. Examples: fishing knots, hooks (with corks over ends for safety), lures. Label all items displayed. Include in your exhibit the following information: the purpose of each item, when or where each item is used.

3106 Build a Fishing Rod - (SF169) - A fishing rod educational exhibit may not exceed 96 inches in length. Exhibit must be mounted on a board. Include with the exhibit: Explanation of cost of materials/components and how many hours required for construction. Label all parts. Necessary components which must be included are grip, line guides (based on manufacturers specifications), guide wraps, and hook keeper. Reel seat needs to be aligned with guides, and guides aligned accurately down rod. Guide wraps of size A to D, nylon or silk thread. Exhibit will be judged on: workmanship, labeling of parts, information, and neatness.

3107 Casting Target - (SF170) - Make a casting target for exhibit and use. Target must be under 48" x 48". The bullseyes must be 2 feet, outer band must be 1 foot in diameter and can have up to 3 rings. The exhibit must be easy to store, durable, and weather resistant. Include the purpose and rules of using your casting target.

3108 Wildlife Harvesting Equipment - (SF171) - Board Exhibit. Display of equipment used in harvesting wildlife. Examples: expended ammunition casings (no live ammunition permitted), steel traps, hide stretchers, fleshers, etc. For displays of shotguns, rifles, or bows, use drawings or pictures. Label all items displayed: the purpose of each item, when or where it is used and personal experiences with the item.

3109 Inventing Wildlife/Fish Harvesting Equipment, Aid or Accessory - (SF168) - Use engineering principles to invent or adapt equipment that helps you harvest fish or wildlife. This could include wildlife calls, adapted fishing pole for shallow water, a blind, decoys, etc. Share your drawing (or adapted plans), how the equipment works, how you tested it, and the results of testing your prototype, and any adjustments you made.

3110 Tanned Hides - (SF172) - Exhibit of a wild animal hide properly processed by the member. If not mounted, must be in a clear clothing bag with hanger. al field experiences, study, OR observations that relate to the exhibit.

3111Taxidermy - (SF172) - Any legal fish, bird, or other wild animal properly processed by the member. No requirement as to mounting. Include the animal's name and the following: information about the exhibitor's personal field experiences, study, OR observations that relate to the exhibit.

asts. There are 3 options. For all options, include a brief description of your experiences in making the tracks so the judges better understand what you did and learned. Positive casts (impressions as they would be in nature) are preferred. Option 1 should show plaster-of-paris tracks of five or more kinds of wildlife along with a picture or illustration of each kind of animal. (OR) - Option 2 should show two or more plaster-of-paris tracks of one specific kind of wildlife and should include a picture or illustration of the animal, what the animal may eat, and what may eat the animal. (OR) - Option 3 should show two tracks and include the animal's habitat needs including preferred food, shelter, water, and space in addition to picture or illustration of the animal.

3113 Wildlife Knowledge Check - (SF159) - Use electrical circuits, pictures, or other methods of teaching wildlife identification or other wildlife conservation or shooting sports related knowledge. Plan size and shape to fit transportation and display; maximum size 24 x 24 inches.

3114 - Houses - (SF165) - Make a house for wildlife. Examples: bird house (bluebird, purple martin, wood duck, kestrel, barn owl, etc.) or bat house; no insect houses. Make the house functional so that dimensions, hole size etc. are appropriate to fit the intended species' needs. Include the following information: 1) the kinds of animal(s) for which the house is intended, 2) where and how the house should be located for best use, 3) any seasonal maintenance needed, and 4) any evidence of your personal observations from experiences.

3115 Feeders/Waterers - (SF166) - Make a bird bath or feeder. Examples: seed, suet, or nectar feeders. Squirrel feeder okay; **no insect feeders**. Include the following information: 1) the kinds of animal(s) for which the water/feeder is intended, 2) where are how the water/feeder should be located for best use, 3) any seasonal maintenance needed, and 4) any evidence of your personal observations or experiences

Department 33 4-H GEOLOGY

Superintendents: Junior Superintendent:

- 1. The exhibit box should be 18" x 24" x 3½". Plexiglas covers are required. Boxes with glass covers WILL NOT be accepted. All specimens are to be arranged across the narrow (18") dimension of the exhibit box, making the exhibit 18" across the top and 24" deep exactly. If a box has a sliding Plexiglas cover, it must be removable from the top. Screws, locks, or other devices that would prevent judges from removing the cover should not be used.
- 2. Each exhibitor is required to identify each display box by placing an identification label bearing name, county or district, and number of specimens in the upper left-hand corner of the Plexiglas cover (inside-use clear double-sided tape to adhere gummed labels), and attaching a label with the same information on the lower right corner of the box (outside).
- 3. Exhibitor may enter in both geology and lapidary sections. Exhibits must be different. Exhibitor may show in only one of the first four geology classes. Exhibitor may also show in geology class 3304 (special exhibit) mineralogy and in one lapidary class.
- 4. Geology specimens should be labeled with the number of the specimen, date collected, specimen name or description, and locality (county) where collected. All specimens must be collected in the state of Kansas (only exception-see #6) during the current 4-H year, which will be allowed starting on the day after the conclusion of the State Fair.
- 5. For the geology classes 3200, 3201, 3202 and 3203, specimens should be mounted in the box by proper groups: rocks, minerals, fossils. Fossils must be identified to the Phylum, Class and Genus level (if possible, or part of Genus cannot be determined). The Genus specimen name is to begin with a capital letter and the whole specimen's name must either be italicized or underlined, not both. Species name is not required however, if a species name is used it must be all lower case and either italicized or underlined. not both. The words "Phylum, Class, Genus" on labels are to be spelled out, not abbreviated. More than one specimen of the same kind of rock or mineral or species of a fossil may be exhibited if this duplication represents different geological formations. Specimen label must show this distinction (Fort Hays limestone, not just limestone; calcite from the Greenhorn Formation, not just calcite; Phylum: Brachiopoda Class: Articulata Genus: Composita from the Morrill Limestone Member, not just Phylum: Brachiopoda Class: Articulata Genus: Composita).
- 6. For geology classes 3200, 3201, 3202 and 3203, all specimens must be collected by the participant (not purchased) from locations in Kansas, with the exception of Tri-State Mining Area specimens collected from these three adjacent counties: Ottawa County, OK; Newton and Jasper Counties, MO. Out of state specimens will not count in the minimum number for the class, nor will they be considered in the judging.
- Grand Champion and Reserve Grand Champion awarded in each section. Grand and Reserve Grand Champion named overall.

Junior Division: ages 7-12 Senior Division: ages 13-18

Section 1-Geology

- Class 3200 **Geology Display 1 -** at least 15 rocks, minerals, and fossils collected during the current 4-H year. Limited to one exhibit box. Only those exhibiting at the State Fair for the first time may enter this class.
- Class 3201 **Geology Display 2 -** at least 30 different rocks, minerals, or fossils, at least 5 of each. Fifteen must be collected during the current 4-H year. Limited to one exhibit box. This class open to those exhibiting either second or third time at State Fair.
- Class 3202 **Geology Display 3** at least 45 rocks, minerals, or fossils, at least 5 of each. Fifteen must be collected during the current 4-H year. Exhibit limited to two boxes. This class is open to those exhibiting either the fourth or fifth time at the State Fair. Identify rocks as igneous, metamorphic or sedimentary. These rock types must be spelled out on labels or have legible key.
- Class 3203 **Geology Display 4** at least 60 rocks, minerals, or fossils, at least 5 of each. Fifteen must be collected during the current 4-H year. Exhibit is limited to two boxes. This class is open to those exhibiting the sixth or more time at the State Fair. Identify rocks as igneous, metamorphic or sedimentary. These rock types must be spelled out on labels or have legible key.
- Class 3204 **Geology Educational Exhibit** Exhibit relating to everyday living; or to a mineral test, a rock formation, geological history, species of a fossil, forms of one mineral, a variation of one kind of rock, archaeological artifacts or Indian artifacts. Digital formats are accepted. List your sources used (example—web addresses or books reviewed as a citation list). Exhibit limited to 4 feet of table space. Care should be taken to use durable materials that with stand fair conditions. Exhibitor may show in the class regardless of number of time he or she had exhibited at State Fair or whether exhibitor has entries in classes 3200, 3201, 3202, or 3203. Exhibitor may also exhibit in lapidary class.
- Class 3205 **Mineralogy** Display a minimum of 15 mineral specimens collected in Kansas, at least 5 of which have been collected during the current 4-H year. The minerals are to be grouped by mineral class (i.e.: Carbonates, Oxides, Silicates) and at least 3 classes must be represented. The member must use one standard display box (see #1). The specimens must be labeled with the number of the specimen, date collected, name of specimen, county where collected and chemical composition (i.e.: CaCo³ for calcite) if known.
- Class 3206 **Fossils** Display a minimum of 15 fossil specimens collected by the participant in Kansas, at least 5 of which have been collected during the current 4-H year. The fossils are to be grouped by Phylum and Class, and at least 3 phyla must be represented (Brachiopoda, Chordata, Mollusca, etc) The member must use one standard display box (see #1). The specimens must be labeled with the number of the specimen; date collected; county where collected; formation, member or source; phylum, class, and genus or part: and geologic age (Cretaceous, Permian, Pennsylvanian, etc) See #5 for additional fossil

labeling expectations.

Class 3207 **Petrology-** Display a minimum of 15 rock specimens collected in Kansas, at least 5 of which have been collected during the current year. Rocks are to be grouped by the 3 rock classes (Sedimentary, Igneous and metamorphic). You must display at least one specimen from each of the three classes. The specimens must fit in one standard display box. Specimen labels must include a specimen number, the date collected, name of specimen, and the county where collected. All rocks must be identified by the formation and member name (Examples: Fort Hays Limestone, Member of the Niobrara Chalk Formation) or source (Examples: Rocky Mountain Outwash, glacial till).

Section 2 - Lapidary

The lapidary will be judged on the following criteria:

The dimensions of the box should be appropriate for the display but should not exceed 18" x 24" x 3.5". The work (polishing and tumbling) must be done by the exhibitor as this is part of the learning process.

All lapidary specimens should be labeled with the following information:

- -Specimen name
- -Place of origin (country, state, or county: county required for Kansas specimens)
- -Purchased or self-collected
- -Date lapidary treatment began
- -Date lapidary treatment completed (treatment completed after the State Fair is considered a new year specimen
- Class 3210 **Lapidary Display 1 -** at least 5 varieties of polished (tumbled) specimens and 5 varieties of unpolished specimens that have not yet received lapidary treatment. These do not have to be an example of 'before and after', nor do they have to be self-collected. Locales must be identified. Only those exhibiting lapidary at State Fair for the first time may exhibit in this class.
- Class 3211 **Lapidary Display 2 -** before-and-after examples of at least 3 varieties of specimens, at least 2 tumble-polished and 2 unpolished of each. There is no requirement that the 4-H member collect any of these. Locales must be identified. Lapidary work should be done during the current 4-H year.
- Class 3212 **Lapidary Display 3** before-and-after examples of at least 6 varieties of specimens, at least 2 tumble-polished and 2 unpolished of each. At least two varieties should be collected from the native site by the 4-H member at least one of which comes from Kansas. Locales must be identified. Lapidary work on at least three varieties should be done during the current 4-H year.
- Class 3213 **Lapidary Display 4 -** before-and-after examples of at least 9 varieties of specimens, at least 2 tumble-polished and 2 unpolished of each. At least three varieties should be collected from the native site by the 4-H member at least two of which comes from Kansas. Locales must be identified. Lapidary work on at least three varieties should be done during the current 4-H year.
- Class 3214 **Lapidary Display 5** Exhibit at least 6 specimens that have not previously been exhibited, which have received lapidary treatment. Lapidary treatment may consist

of polishing, and end, face, or flat lapping. Specimens must represent at least 3 different varieties and include at least three cabochons of any size or shape, only one of which may be free-formed. A cabochon is a style of cutting in which the top of the stone forms a domed or curved convex surface. Three of the specimens must be mounted into jewelry findings. Special lapidary exhibits should be entered in class 3214.

Department 34 4-H SHOOTING SPORTS

1. Exhibits in this division are open to educational displays, promotional posters or experiential. Follow copyright laws as you are preparing your exhibits. Take care to select durable materials to withstand Fair conditions. The education display must be standard trifold only, must not exceed the trifold, unless there is a topper that sits on top of the board and does not take up table space. No additional table space will be available for promotional brochures or display items, content not to exceed display board borders. Failure to follow size limitations will drop ribbon placing one ribbon color.

- 2. No "live" ammunition containing propellant or explosive powders is prohibited. An inert substitutes must be used in lieu of powder and "live" ammunition, the substitution must be clearly described on the back of the poster, display or in a notebook. Please remember that neither the Rush County Fair Board or the department of 4-H Youth Development, or K-State University Research and Extension are liable for any loss or damage of any personal property included as part of your display.
- Exhibitor name, county/district, age and year in project should be on the front lower left of the poster, display or notebook.
- 4. Poster size must not exceed 22" x 30", content not to exceed poster borders. Flat poster/foam core/cardstock board. Exhibits exceeding the size guidelines will be penalized one ribbon color.

Exhibits will not be accepted if they are related to reloads.

- Class 3305—**Practice Game or Activity** (SF255) invent or adapt an activity to practice or teach a project skill. Include pictures of youth playing the game, testimonials or 4-H members who played the game, what skill is being worked on, and directions for the game. Explain how you came up with the game or adapted it to fit the needs of your group members.

Department 35 4-H AG MECHANICS WELDING

- The Ag Mechanics Welding project exhibit is starting with an emphasis on welding and metallurgy from repairing or repurposing items to the fabrication of new items. It will expand as the project area grows.
- 1. 4-H members must be currently enrolled in the Kansas 4-H Ag Mechanics-Welding project to exhibit in this division.
- 2. Exhibits must have been constructed or repaired during the current 4-H year.
- 3. Following are basic guidelines for this department. All rules from the Kansas State Fair for this project must be followed. KSF Rules are posted at www.walnutcreek.k-state.edu/4-h/county-fair.html
- 4. Wheeled exhibits must utilize a breaking mechanism which prevents the exhibit from freely rolling while on display.
- 5. Cutting surfaces, such as blades or knives, are to have a protective covering over them to prevent injury. The covering should be easily removed and reinstalled for judging. Foam "pool noodles" and multiple layers of cardboard are acceptable.

- 6. Exhibits that include weaponry of any kind will be disqualified. Weaponry is defined as any instrument, possession, or creation, physical and/or electrical that is intended to be used to inflict damage and/or harm to individuals, animal life, and/or property.
- 7. If the exhibit is powered by flammable liquids (gas, propane, kerosene, etc.) the fuel tank and lines should be drained and allowed to dry, to avoid spills and potential fires.
- 8. Electric powered (battery, corded, solar, or alternative energy) should have a primary shutoff or disconnect switch 13. If a safety violation is noted by the judges, superintendent, or other staff, the exhibitor's exhibit, at the judges' discretion, will receive a deduction in ribbon placement or a participation ribbon.
- 9. The exhibitor's name(s) and county or district must be tagged or labeled in a prominent location on the display.
- 10. Each exhibitor is required to complete the "4-H Ag Mechanics Welding Exhibit Form" which is available through your local K-State Research and Extension office. This form must be attached to the outside of a 10" x 13" manila envelope. Do not tie the envelope to the exhibit.
- 11. Each exhibit must include an Ag Mechanics information packet. Each exhibit information packet should include the following items:
 - a. Bill of materials for the project with associated costs, scrap items used may be listed as having a \$0.00 cost b. 1 to 5 pages of photos showing work on the exhibit, preferably from a beginning state to final or completed state c. If appropriate schematics or working drawings relating to the creation or repair
 - d. If appropriate operating instructions
- 12. Additional information and rules can be found in the Kansas State Fair book. Exhibits are to have a clear link to Ag Mechanics/Welding. Posters and educational displays are limited to 3' x 4' by 2" deep. Educational project notebook must be organized in a 3-ring binder.

Department 36 4-H Building Block Engineering

Superintendents: Jewell Dinsmore Junior Superintendent: Travis Ross

- Description: The BBE (Building Block Engineering) exhibit area focuses on using architectural blocks ("Legos") to construct dioramas. This project allows youth to explore architectural design in a three dimensional space.
- 1. 4-H members must be currently enrolled in the Kansas 4-H BBE (Building Block Engineering) project to exhibit in this division.
- 2. Each exhibitor may enter six exhibits. Exhibits must have been constructed during the current 4-H year. Counties or districts should select only top blue or purple ribbon exhibits which meet the specific State Fair guidelines.
- 3. Total exhibit dimensions may not exceed 2 feet high, by 2 feet wide, by 2 feet deep. Minimum exhibit dimensions must be at least 6 inches wide and deep.
- 4. All exhibits are required to be placed in a sturdy see through enclosure with a top, bottom, and 4 sides. A plastic tote would be an acceptable enclosure. This is to keep exhibit parts from being "scattered to parts unknown" at the fair. The outer dimensions of the enclosure are part of the total exhibit dimensions.
- 5. All components used in construction should be dust free, clean, free of chips, scuffs, or cracks
- 6. The primary building component should be interlocking blocks, commonly referred to by the brand name of Lego®
- 7. Other architectural components can be integrated into dioramas to illustrate architectural aspects that may be difficult to convey with traditional interlocking blocks (for example, marbles for small round objects).

- 8. The use of existing "store bought" sets for major architectural elements of the display is not allowed, use of figurines from sets is allowed as are using individual bricks to create something different than the architectural component of the set it came from.
- 9. Displays must have significant architectural components (walls, windows, doors, roofs, canopies flying buttresses, etc.), landscapes are discouraged.
- 11. Architectural elements should have a consistent look, walls with no pattern or consistency will be deducted one ribbon placing.
- 12. Gaps or cracks should not be visible between assembled blocks.
- 13. Doors should open and close, windows can be either fixed or open and close.
- 14. Vehicles that are intended to stay in a single place should be affixed to base plates with sticky tack, hot glue, or other method.
- 15. Reveals that show the inside of a structure are acceptable, such as only having three walls to allow an unobstructed view into a room.
- 16. Mechanical enhancements or motion elements that add motion to the diorama are acceptable and encouraged. If used judges should be able to use them and instructions should be provided for operation.
- 17. Artistic designs with no architectural design/components are not permitted and two ribbon placings will be deducted
- 18. The exhibitor's name and county or district must be tagged or labeled in a prominent location on the display
- 19. Entry of just a packet without an accompanying exhibit is not a sufficient exhibit.
- 20. Each exhibitor is required to complete the "4-H Building Block Engineering Exhibit Information Form" which is available through your local K-State Research and Extension office. This form must be attached to the outside of a 10" x 13" manila envelope. Do not tie the envelope to the exhibit. http://blocks.engtech4ks.com/
- 21. Each exhibit information packet should include the following items:
 - A. 1 to 5 pages of photos showing work on the exhibit, preferably from a beginning state to final or completed state. Final pictures help in determining where a part might go in case something comes loose.
 - B. If appropriate operating instructions for mechanical portions of the diorama
